

Telehealth and AAC: Feature Matching, Intervention, and Contemporary Issues

Course Description

Speech-language pathologists (SLP) often report limited training in augmentative and alternative communication (AAC) (ATIA, 2012; Johnson & Prebor, 2019). Since early 2020, an outbreak of COVID-19 required many clinicians to transfer their caseloads from in-person to telehealth services. Limited training in this service modality may result in additional barriers to high-quality AAC services. The purpose of this presentation is to prepare SLPs to deliver effective AAC assessments and evidence-based interventions via telehealth. Barriers and potential solutions for assessment and treatment will be discussed. The presenter will also review contemporary issues related to telehealth service delivery in AAC.
